Contract Information: The new Contract and Port Supplement went into effect Saturday May 23, 2015 which includes, wages and some new contractual language.

When Lasher's are ordered a lashing Foremen shall be employed to supervise up to 20 Longshoremen. Port Supplement 10.1421 **(This Rule Applies to Lash Back Only)**

When a container yard is operating, a Dock Foreman shall be employed to supervise the operation and may only supervise up to 45 Longshoremen. Port Supplement 10.143

When a rail yard is operating, a Dock Foremen shall be employed to supervise the operation and may only supervise up to 42 Longshoremen. Port Supplement 10.144

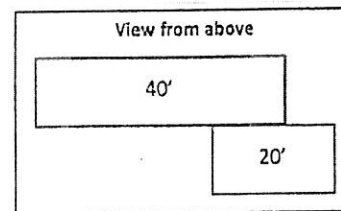
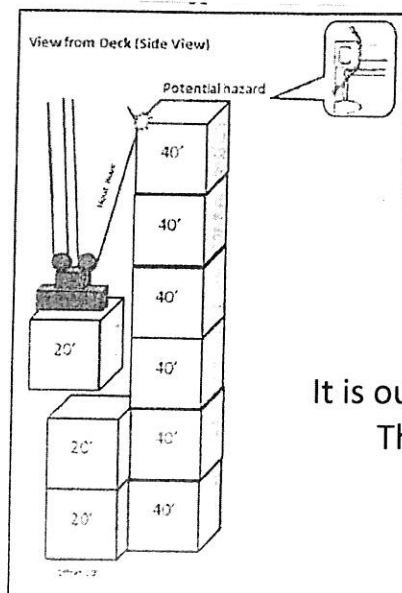

Offset 20' containers, abreast of 40' containers, that cannot be twinned shall never have more than a two (2) tier height differential when being discharged and or loaded.
