This selection shall be made considering information available to the Foremen at the time, which may include job categories, knowledge, skills, ability and with regard to maintaining a safe and efficient operation. All Foremen are to select Longshore workers for daily elevations consistent with this policy. Daily elevations must be made in a **nondiscriminatory manner!!**

**Steady Positions:** As a reminder of the Coast Arbitrator's decision in 2010, Local 94's **members** and the officers will take no adverse or beneficial action towards a member based on his or her decision to apply or not to apply for steady position.

As outlined in the Foreman's Steady Pay Guarantee, Letter of Understanding, The Employers will use open interview process per past practice to select steady Foremen.
